1) ENTIRE AGREEMENT: This agreement contains the entire understanding between GEOFFREY GUY WEEKS and THE CLIENT. It supersedes all prior and simultaneous agreements between the parties. The only way to change or add to this agreement is to do so in writing, and providing the document is signed by all the relevant parties.

2) COOPERATION: The parties agree to positive cooperation and communication for the best possible result within the definition of this assignment. GEOFFREY GUY WEEKS is not responsible for unsatisfactory or missed performances due to a lack of communication from THE CLIENT as to event locations, performance expectations, setup information, or other critical details. THE CLIENT agrees to provide GEOFFREY GUY WEEKS with recordings of desired songs if requested.

3) \*PRE-EVENT CONSULTATION: The parties agree to a pre-event consultation before the wedding date in order to finalize the actual performance times, locations, and other details of the day. This consultation may take place in-person or by phone no later than one week prior to the wedding date.

4) RESERVATION DEPOSIT: Upon your signature and 25% deposit, GEOFFREY GUY WEEKS will reserve the time and date agreed upon, and will not make other reservations for that time and date. Your date will not be reserved until this point. For this reason, the Reservation Deposit of 25% is non-refundable. The Reservation Deposit is to be paid at time of signing the contract. The Reservation Deposit is applied towards the contracted performance price. THE CLIENT understands and agrees that the entire amount owed for the performance described in this contract is due no later than the time of the performance.

5) SERVICE PROVIDER COOPERATION: THE CLIENT and GEOFFREY GUY WEEKS agree that positive cooperation and punctuality are therefore essential. THE CLIENT will direct all other service providers (photographer, DJ, wedding planner, etc.) to provide any needed information and cooperation to the musician.

6) \*EVENT GUIDE: GEOFFREY GUY WEEKS requires assistance on the wedding date to prepare for the event. THE CLIENT will designate an "event guide" who has the responsibility of meeting GEOFFREY GUY WEEKS at the event, directing/assisting with setup, and provide any relevant information needed. The event guide may be THE CLIENT, but is typically a family member, close friend, or wedding planner.

7) ABUSIVE BEHAVIOR: GEOFFREY GUY WEEKS will not tolerate verbally or physically abusive behavior. If THE CLIENT is unable to control the conduct of their guests, resulting in an unacceptable degree of misconduct, or if the conduct of any of their guests damages the equipment of the musician, it will result in the early or immediate departure of the musician. THE CLIENT understands that in such an event, no refunds will be granted.

8) METHOD OF PAYMENT: Payment may be by cash or check to Geoffrey Guy Weeks. If THE CLIENT desires to make a credit card payment through Paypal, they must notify GEOFFREY GUY WEEKS.

9) LATE PAYMENT FEE: If payments are not delivered to GEOFFREY GUY WEEKS by the required date, services may be refused by GEOFFREY GUY WEEKS. If GEOFFREY GUY WEEKS does allow a late payment, there is a \$50.00 late payment fee added to the total fee.

11) CANCELLATION: In the event that THE CLIENT cancels the contracted services for wedding music outlined in this contract before the wedding takes place, the deposit will be forfeit. GEOFFREY GUY WEEKS agrees to refund all additional paid money to THE CLIENT.

12) RIGHT OF WITHDRAWAL: GEOFFREY GUY WEEKS's discovery of new information, changes to agreed circumstances, or other factors which tends to circumvent its policies may result in its withdrawal. Non-cooperation; changes in locations, facilities or available times; missed appointments and late payments

are examples of contributing factors. Should GEOFFREY GUY WEEKS initiate the withdrawal, all fees will be returned, excluding deposit.

13) LIMIT OF LIABILITY: In the unlikely event of severe medical, natural, or other emergencies, it may be necessary to retain an alternative musician. GEOFFREY GUY WEEKS will make every effort to secure a replacement musician able and/or willing to provide a similar package as chosen in this contract at the same/similar fee. If such a situation should occur and a suitable replacement is not found, responsibility and liability is limited to the return of all payments received from THE CLIENT to GEOFFREY GUY WEEKS. The limit of liability shall not exceed the contract price stated herein.

14) SEVERABILITY: If any provision of this agreement is held to be invalid or unenforceable under the law, the validity of this agreement as a whole shall not be affected, and the other provisions of the agreement shall remain in full force and effect.

15) AMENDMENTS: This contract has been freely negotiated and shall be recognized as the entirety of the agreement. Only those changes or modifications specifically placed in writing, attached, dated and signed by THE CLIENT and GEOFFREY GUY WEEKS at the time of acceptance of this contract shall be recognized as amendments to this contract.
